(c) Of the funds appropriated in Schedule (10), up to \$7,000,000 may be used by the Chancellor of the California Community Colleges for the purpose of procuring and/or developing E-Transcript and E-Planning tools. Prior to the expenditure of these funds, the Chancellor of the California Community Colleges shall submit a proposed expenditure plan to the Department of Finance and the Joint Legislative Budget Committee.

(d) Of the funds appropriated in Schedule (10), up to \$10,000,000 may be used by the Chancellor of the California Community Colleges for the purpose of procuring and/or developing a common assessment system as described in Chapter 615 Section 78219 of the Education Code. Prior to the expenditure of these funds, the Chancellor of the California Community Colleges shall submit a proposed expenditure plan to the Department of Finance and the Joint Legislative Budget Committee.
